

## **Terms of Use**

These Terms and Conditions of Use (the "Terms of Use") apply to the Milvik App and associated websites and microsites (collectively, the "Sites"). The Sites are the property of PT Milvik Indonesia ("Milvik") and its licensors. BY USING THE SITES, YOU AGREE TO THESE TERMS OF USE; IF YOU DO NOT AGREE, DO NOT USE THE SITES.

Milvik reserves the right, at its sole discretion, to change, modify, add or remove portions of these Terms of Use, at any time. It is your responsibility to check these Terms of Use periodically for changes. Your continued use of the Sites following the posting of changes will mean that you accept and agree to the changes. As long as you comply with these Terms of Use, Milvik grants you a personal, non-exclusive, non-transferable, limited privilege to enter and use the Sites.

## **Content**

All text, graphics, user interfaces, visual interfaces, photographs, trademarks, logos, sounds, music, artwork and computer code (collectively, "Content"), including but not limited to the design, structure, selection, coordination, expression, "look and feel" and arrangement of such Content, contained on the Sites are owned, controlled or licensed by or to Milvik, and is protected by trade dress, copyright, patent and trademark laws, and various other intellectual property rights and unfair competition laws.

## **Your Use of the Sites**

You may not use any "deep-link", "page-scrape", "robot", "spider" or other automatic device, program, algorithm or methodology, or any similar or equivalent manual process, to access, acquire, copy or monitor any portion of the Sites or any Content, or in any way reproduce or circumvent the navigational structure or presentation of the Sites or any Content, to obtain or attempt to obtain any

## **Indemnity**

## **Governing Law; Dispute Resolution**

You agree that all matters relating to your access to or use of the Sites, including all disputes, will be governed by the laws of the Republic of Indonesia without regard to its conflicts of laws provisions. You agree to the personal jurisdiction by and venue in Dhaka. No recovery may be sought or received for damages other than out-of-pocket expenses, except that the prevailing party will be entitled to costs and attorneys' fees. In the event of any controversy or dispute between Milvik and you arising out of or in connection with your use of the Sites, the parties shall attempt, promptly and in good faith, to resolve any such dispute. If we are unable to resolve any such dispute within a reasonable time (not to exceed thirty (30) days), then either party may submit such controversy or dispute to mediation. If the dispute cannot be resolved through mediation, then the parties shall be free to pursue any right or remedy available to them under applicable law.

## **Miscellaneous**

You may not use or export or re-export any Content or any copy or adaptation of such Content, or any product or service offered on the Sites, in violation of any applicable laws or regulations.

If any of the provisions of these Terms of Use are held by a court or other tribunal of competent jurisdiction to be void or unenforceable, such provisions shall be limited or eliminated to the minimum extent necessary and replaced with a valid provision that best embodies the intent of these Terms of Use, so that these Terms of Use shall remain in full force and effect. Milvik's failure to insist on or enforce strict performance of these Terms of Use shall not be construed as a waiver by Milvik of any provision or any right it has to enforce these Terms of Use, nor shall any course of conduct between Milvik and you or any other party be deemed to modify any provision of these Terms of Use. These Terms of Use shall not be interpreted or construed to confer any rights or remedies on any third parties.
